## Ethics Statement for Research and Development Report (RR)

Research and Development Report (RR) in Japan Aerospace Exploration Agency upholds the highest standards in scholarly publishing. Submission to the Editorial Committee of RR implies that authors have read and complied with RR policies on this ethics statement. The Editorial Committee reserves the right to reject without review any manuscript that the Editor believes may breach these policies.

#### Submission

Submission to the Editorial Committee of RR implies that all authors have seen and approved of the manuscript, have agreed to its submission, and have the right to publish their work

Submission to the Editorial Committee of RR also implies that the manuscript is original work that has not been previously published in any language and is not under consideration elsewhere. When submitting their manuscript, authors must inform the Editor if any related publications are under consideration or in press elsewhere.

### Authorship

The Editorial Committee of RR encourages authors to follow the International Committee of Medical Journal Editors (ICMJE) Recommendations on 'Defining the Role of Authors and Contributors'. In particular, the ICMJE recommends that each author must have made a substantial contribution to the conception or design of the work, or the acquisition, analysis or interpretation of data for the work; drafted the manuscript or revised it critically for important intellectual content; approved the final version of the manuscript for publication; and agreed to be held accountable for all aspects of the work. Any contributor who has met these four criteria should be an author on the manuscript. Contributors who have not met all four criteria should not be authors of the manuscript but may be included in the manuscript's Acknowledgements.

Submission to the Editorial Committee of RR implies that all authors have seen and approve of the author list. Any amendments to the author list after manuscript submission (such as changing the order of names, or adding or removing names) must be approved by all authors and the Editor.

# Unoriginal material

By submitting a manuscript to the Editorial Committee of RR, authors warrant that it represents original work. Manuscripts may be screened for unoriginal material using CrossCheck. By submitting a manuscript to the Editorial Committee of RR, authors agree to this screening. If CrossCheck screening reveals an unacceptable level of unoriginal material, the Editor may reject or retract the manuscript.

#### Image integrity

All images in a submitted manuscript must accurately reflect the original data on which they are based. Images may be digitally manipulated or processed, as long as any adjustments are kept to a minimum, are applied to the entire image, and meet community standards. No individual parts of an image should be moved, removed, added or enhanced. Any significant or non-linear image adjustments should be described clearly in the accompanying caption.

The editors reserve the right to request original, unprocessed images from the authors to aid in their assessment of a submitted manuscript. Failure to provide requested images may result in a manuscript being rejected or retracted.

## Reproducing copyrighted material

If a manuscript submitted to the Editorial Committee of RR contains published or previously unpublished material (such as images) that is not the authors' copyright, it is the authors' responsibility to obtain any necessary permissions to reproduce the material. These permissions should be included with the manuscript submission and the source of the material and copyright holder must be clearly and appropriately acknowledged and attributed.

### Availability of data and materials

When referring to publicly available data and materials, such as public repositories or commercial manufacturers, authors must include relevant sources (e.g. accession numbers or company details) in their manuscript as appropriate.

Submission of a manuscript to the Editorial Committee of RR implies that the authors are willing and able to grant reasonable requests to share data and materials. Authors who are unable to do so, because of employer or other confidentiality requirements, should explain why at the time of submission. The Editorial Committee of RR may require a brief note of explanation to be inserted in the manuscript upon acceptance.

Authors should make data and materials relevant to their manuscript available as Supplementary Material, or deposit it in appropriate public databases or digital repositories before the date of publication.

### Conflicts of interest

A conflict of interest exists when there are actual, perceived or potential circumstances that could influence an author's ability to conduct and report research impartially. Such circumstances could include (but are not limited to) competing commercial or financial interests, commercial affiliations, consulting roles, or ownership of stock or equity.

In the interests of transparency, all authors must declare any conflicts of interest in relation to their submitted manuscript. Authors should list all funding sources for their work in the Acknowledgements section of their manuscript.
